Educational Services - The Indiana Karst Conservancy (IKC) has many volunteers who provide educational services to schools groups, conservation groups, youth groups (e.g., Scouts Troops), developers, government agencies, and the general public who live in karst areas. In 2008, volunteers presented at over 25 events with direct contact to over 3,000 individuals. In addition to our direct outreach, we have participated in authoring newspaper and magazine articles, have educational materials on our website, and have provided educational opportunities through our property holdings. The IKC owns five properties that provide visitors with various experiences including "wild" caving at Sullivan, Wayne, Buddha, and Robinson Ladders caves, interpretive hiking on a trail at the Buddha property, and easy access to a large karst spring/resurgence at our Orangeville Rise property (both the Buddha and Orangeville Rise properties are dedicated State Nature Preserves). We also publish a quarterly newsletter to promote karst education opportunities and report on accomplishments. This newsletter is available on our website.

Land Acquisition and Stewardship - The Indiana Karst Conservancy over the years has acquired five conservation properties and one conservation easement to protect and promote karst education. In 2008, we did not acquire any new properties, but did expend resources (primarily volunteer labor) in restoration and stewardship on our properties. This included planting 1,200 trees at our Buddha preserve, completing an educational kiosk at the Buddha preserve, preparing for an open field restoration/conversion at our Robinson Ladder preserve, as well as general maintenance at our other preserves (trail mowing, trash pick up, invasive plant control, etc).

Karst Protection and Research - In 2008 we collaborated with Bat Conservation International to restore and protect a potential hibernacula for the Indiana bat, a federally endangered species. This included removing a physical blockage and installing a bat-friendly gate. The IKC also assisted the Indiana Department of Natural Resources on a research project to install instrumentation to collect temperature and humidity data in bat hibernacula.

The second grant was for \$250 to the Center for North American Bat Research & Conservation for research to study White-Nose Syndrome in bats.
