Wyandotte Cave Gate - The IKC has developed gate construction skills over the years and when the USFWS and Indiana DNR determined that a new gate on Wyandotte Cave (to replace the old gate) was necessary, they contacted the IKC to perform the work. The project was a private/public agency partnership with oversight by the agencies, but actual work performed by IKC volunteers. Funding for the project was provided by private entities that would cover materials and in-kind volunteer compensation for design, construction, painting, and project management. The project was started in April 2013 and completed in July 2013. The benefit of the project was to better protect the Indiana bat (Myotis sodalis) which hibernate in the cave during the winter. The old gate was located approximately 400 feet into the cave. Since that gate was constructed in 1991, the clustering habits of the bats have shifted such that 20% of the population was now hibernating outside the old gate. The new gate is located much closer to the entrance, protecting 100% of the bats. Wyandotte Cave is one of the largest hibernacula for this species, which is listed as endangered.

Educational Services - The IKC has many volunteers who provide educational services to school groups, conservation groups, youth groups (e.g., Scout troops), developers, government agencies, and the general public who live in karst areas). In 2013, volunteers presented at a number of events. In addition to our direct outreach, we have participated in authoring newspaper articles, have educational materials on our website, and have provided educational opportunities through our property holdings. The IKC six properties provide visitors with various opportunities including "wild" caving experiences, interpretive hiking on trails, and easy access to a large karst spring/resurgence. We also publish a quarterly newsletter to promote karst education opportunities and report on accomplishments. This newsletter is distributed for free to our members and available on our public website.

Land Stewardship - The Indiana Karst Conservancy (IKC) over the years has acquired six conservation properties and one conservation easement to protect and promote karst education. In 2013, we continued to expended significant resources (funds and volunteer labor) at our Shawnee Karst Preserve in Lawrence County. This included constructing 1.8 miles of nature trails, cleaning up a second trash-filled sinkhole, planting 400 hardwood trees in a field, repairing a second wildlife pond, and restoring a large sinkhole pond. Other stewardship/restoration work was performed at our other preserves.
